CERTIFICATE OF WATER RIGHT

This Is to Certify, That CLARENCE E. HOLMES

of Kimberly , State of Cregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of North Fork John Day River, Dry Creek, and spring a tributary of for the purpose of irrigation of 135.3 acres and stock,

under Permit No. 17030 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 28, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.39 cubic feet per second, being 3.14 c.f.s. from River, 0.22 c.f.s. from Dry Creek, 0.02 c.f.s. from spring for irrigation, and 0.01 c.f.s. from spring for stock,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW4 SE4, Section 1, T. 9 S., R. 26 E., W.M. Lot 3 (NW4 SW4), Section 7, T. 9 S., R. 27 E., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fourtieth of one cubic foot per second per acre, or its equivalent for each acre irrigated during any month and shall be further limited to a total diversion of not to exceed 5 acre feet per acre for each acre irrigated during the irrigation season from April 1st to Sept. 30th of each year, from North Fk. John Day River and this appropriation shall be limited to 1/40 of one cubic foot per second for each acre irrigated prior to June 1, and thereafter 1/80 of one cubic foot per second or its equivalent for each acre irrigated and shall be limited to a diversion of not to exceed 1 acre foot per acre "see below and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is apparate is as follows:
