**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That FRED L. ALLEN**

of 1385 Cooley Road, Woodburn, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well a tributary of Pudding River for the purpose of irrigation of 23.5 acres

under Permit No. G-244 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 15, 1956

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.17 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$  SE $\frac{1}{4}$  as projected within Cooley DLC 41, Section 8, T. 5S., R. 1W., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is part of that described as follows:

Beginning at a stone in the Southwest corner of the Cooley DLC.; thence N. 24° E. 8.91 chs. to a stone; thence S. 86°45', E. 22.16 chs. to a stone which is the place of beginning of the tract of land herein described; thence N. 32°14' E. 30.53 chs. to a plow share in the center of the County Road; thence S. 89°34' E. 8.197 chs. to another plow share in the center of said County Road; thence S. 31°58' W. 13.197 chs. to a stone; thence S. 56°55' E. 2.95 chs. to a harrow tooth in the center of a public road; thence S. 37°39' W. in said center line of said road, 17.046 chs. to an iron bar; thence N. 86°45' W. 9.573 chs. to the place of beginning. Save and except the tract of land conveyed to Glen C. Hermanson and Thelma L. Hermanson by deed recorded December 9, 1947.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
