CERTIFICATE OF WATER RIGHT

This Is to Certify, That JOHN H. SHURTZ

of **Route 1, Box 21, Riddle** State of **Oregon**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **Cow Creek** a tributary of **South Umpqua River** for the purpose of **irrigation of 14.2 acres**

under Permit No. **25786** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **August 28, 1958**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.20 cubic foot per second**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **NE $\frac{1}{4}$ NE $\frac{1}{4}$** , as projected within **Riddle DLC 39, Section 32, T. 30 S., R. 6 W., W.M.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-seventieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **3 $\frac{1}{2}$ acre feet** per acre for each acre irrigated during the irrigation season of each year, provided further that the right to the use of water is limited to the period when the flow of water in Cow Creek is **11.0 c.f.s.** or more at its mouth,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.2 acre **NE $\frac{1}{4}$ NE $\frac{1}{4}$** , as projected within **W. Riddle DLC 39**
2.8 acres **SE $\frac{1}{4}$ NE $\frac{1}{4}$** , as projected within **W. Riddle DLC 39**
1.8 acres **Lot 4 (SE $\frac{1}{4}$ NE $\frac{1}{4}$)**
Section 32
0.1 acre **Lot 2 (NW $\frac{1}{4}$ NW $\frac{1}{4}$)**
0.5 acre **NW $\frac{1}{4}$ NW $\frac{1}{4}$** , as projected within **W. Riddle DLC 39**
2.8 acres **SW $\frac{1}{4}$ NW $\frac{1}{4}$** , as projected within **W. Riddle DLC 39**
6.0 acres **Lot 1 (SW $\frac{1}{4}$ NW $\frac{1}{4}$)**
Section 33
T. 30 S., R. 6 W., W.M.

Land on which water is to be used is part of that described as follows:

Beginning at a point 10.00 chs. N. and 9.25 chs. W. from the 1/4 corner between Section 32 and 33 of T. 30 S., R. 6 W., W.M., Douglas County, Oregon; thence E. 19.0 chs. thence N. 13.40 chs. to the center of Cow Creek, thence following the center of Cow Creek S. 86 1/4° W. 4.50 chs, thence S. 82 3/4° W., 2.89 chs, thence S. 80 1/4° W. 3.00 chs., thence S. 64 1/4° W. 1.50 chs, thence N. 89 1/4° W. 7.33 chs., thence S. 11.68 chs. to place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
