of P.O. Box 651, Riemath Falls , State of Oregon , her made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Weyerhaeuser Timber Co. wells No. 3 & 4 a tributary of Klamath River for the purpose of manufacturing and domestic

under Permit No. G-342 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 1, 1956

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.97 cubic foot per second, being 0.57 cfs. for menufacturing and 0.04 for domestic uses in 26 houses, and 0.36 c.f.s. for domestic uses within the plant

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NWL SWL, Section 18, Township 39 South, Range 9 East, W.M. Well No. 3 is 505 ft. S. and 460 ft. E. Well No. 4 is 400 ft. S. and 500 ft. E., both from W. corner, Section 18.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to  $\_$   $\_$   $\_$   $\_$   $\_$  of one cubic foot per second per acre,
