CERTIFICATE OF WATER RIGHT

This Is to Certify, That BILL I. SCHOFIELD

of **Star Rt., Gales Creek**, State of **Oregon**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **Gales Creek** a tributary of **Tualatin River** for the purpose of **irrigation of 1.5 acres**

under Permit No. **24220** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **May 9, 1956**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.02 cubic foot per second**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **SW $\frac{1}{4}$ NE $\frac{1}{4}$** , as projected within **Parson DLC 50**, **Section 6, T. 1 N., R. 4 W., W.M.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$ acre feet per acre** for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.1 acre **NW $\frac{1}{4}$ NE $\frac{1}{4}$**
1.2 acres **SW $\frac{1}{4}$ NE $\frac{1}{4}$**
0.2 acre **SE $\frac{1}{4}$ NW $\frac{1}{4}$**
as projected within **Parson DLC 50**
Section 6
T. 1 N., R. 4 W., W.M.

Land on which water is to be used is part of that described as follows:

Beginning at a point in the center of county road No. 1312 and on the westerly line of that certain property conveyed to Emil Jossy by deed as described on page 521 of deed book 175, which said beginning point bears north 9°20' east 962.6 feet from a stone marking the center of section 6, township 1 north, range 4 west of the Willamette Meridian; running thence north 38°12' west in the center of said county road 759 feet to a point from which an iron pipe bears north 51°48' east 30 feet; thence north 51°48' east at right angles with said county road 330 feet to an iron pipe; thence south 38°12' east parallel with said road 330 feet to an iron pipe; thence south 50°24' east 108.3 feet to an iron pipe on the westerly line of the said Jossy tract; thence south 9°20' east 478.5 feet to the place of beginning. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
