**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That JOHN W. & DAISY M. WILMARTH**

of Rt. 1, Box 63, Clatskanie, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Columbia River a tributary of Pacific Ocean for the purpose of irrigation of 10.1 acres

under Permit No. 23178 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 2, 1954

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.13 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 3 (NE $\frac{1}{4}$  NW $\frac{1}{4}$ ), Section 23, T. 8 N., R. 4 W., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.2 acres Lot 3 (NE $\frac{1}{4}$  NW $\frac{1}{4}$ )  
6.9 acres Lot 3 (SE $\frac{1}{4}$  NW $\frac{1}{4}$ )  
Section 23  
T. 8 N., R. 4 W., W.M.

Land on which water is to be used is part of that described as follows:

Beginning at a point that is E. 1360.0 ft. and N. 300.0 ft. from the  $\frac{1}{4}$  section corner between Sections 22, and 23, T. 8 N., R. 4 W., W.M., thence from said point of beginning E. 300.0 ft.; thence north 1622 ft. to the S. bank of the Columbia R. and N. edge of the Beaver Drainage District; thence down the bank of said river, N. 72° 36' W. 314.4 ft.; thence S. 1716.0 ft. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
