## CERTIFICATE OF WATER RIGHT

## This Is to Certify, The K. B. HEISER

of Box 65. , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Coquille River for the purpose of a tributary of Pagific Ocean

irrigation of 31.0 acres

under Permit No. 23522 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 30, 1955

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an anagua actually beneficially used for said purposes, and shall not exceed 0.39 cubic foot per same

or its equipalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Let 7 (NW SE 1), Section 36, T. 28 S., R. 13 W., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 scree feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is

appurtenant, is as follows:

15.6 acres NEt SEt 11.4 acres Lot 7 (NW SE-0.8 acres Lot 6 (SW) 3.2 acres Lot 6 (SET SE Section 36 T. 28 S., R. 13 W., W.M.

Land on which water is to be used is part of that described as follows: K. E. & A. Nielsen:

Beginning at a point which is 898.26 ft. South and 545.82 ft. West of the northeast corner of the SE2 of Section 36, T. 28 S., R. 13 W., W.M., Coos County Oregon; thence West 1450 ft. to low water line of the Coquille River; thence down stream northerly 449.8 ft. thence East 1388 ft.; thence South 449.8 ft. to the place of beginning. Dorleska E. Schroeder: Beginning at a point which is 898.26 ft. South and 545.82 ft. West of the northeast corner of the SEt of Section 36, T. 28 S., R. 13 W., W.M., Coos County, Oregon; thence West 1450 ft. to the low water line of the Coquille; thence up stream along said low water line to a point south of the point of beginning; thence North to beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
