or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 2 (NW NET), Section 2, T. 17 S., R. 4 W., W.M.

Riverview Acreage)

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is

appurtenant, is as follows:

8 acres Lot 2 (NW# NE#) Section 2 T. 17 S., R. 4 W., W.M.

Land on which water is to be used is part of that described as follows: Lots 3 and 4 of Hansen's Riverview Acreage, except: Commence at the Southwest corner of said Lot 3 said point being on the center line of Spring Creek Drive (Riverview St.) thence North along the west line of Lot 3, 298.43 ft., thence North 89° 46' East 100 ft. to an intersection with the Southerly bank of Spring Creek thence Easterly and Southerly along the bank of Spring Creek on the following courses South 73° 29' East 104.5 ft., South 51° 30' East 35.968 ft. South 17° 22' East 39.65 ft. South 5° 35' West 209.12 ft. to the South line of said Lot 3, thence South 89° 46' West 219.38 ft. to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
