CERTIFICATE OF WATER RIGHT

This Is to Certify, That HOMARD E. TAYLOR

of Rt. 1 Box 55 Lebanon , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Santiam River a tributary of Willamette River

irrigation of 4.0 acres

for the purpose of

of the State Engineer, and that said right to the use of said waters under Permit No. 25098 has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 26, 1957

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.05 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 8 (SW NE 1), Section 19, T. 12 S., R. 1 W.,

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 scre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

> 1.3 acres Lot 8 (SW2 NE 2.7 acres Lot 7 (NW SEZ) Section 19 T. 12 S., R. 1 W., W.M.

Land on which water is to be used is part of that described as follows:

Beginning at a point S. 85° 30° K. 7.20 chains from the Northwest corner of the Geo. Klum DLC No. 39 and running thence North 4 chains to an iron rod; thence East 1.98 chains to the old channel of the Santiam River; thence N. 72° W. along said old channel 8.20 chains to a point due East of the Southeast corner of the Cheadle DLC No. 55; thence West 7.34 chains to a point 5 chains East of the Southeast corner of said Claim 55; thence South 20 ft; thence West 4.55 chs. to an iron pipe; thence S. 36° 50° E. 6.86 chains to an iron rod; thence Southeasterly 617.1 ft. to a point or beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
