## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That WILLIAM UPPENDAHL

of Box 35, Gervais , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of one wall

a tributary of Pudding River irrigation of 8.2 acres

for the purpose of

under Permit IIo. G-307 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 30, 1956

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.10 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 3 (SW4 NE1), Section 7, T. 6 S., R. 1 W., W.M. Well is 5.5 chs. W. & 2.8 chs. N. of most southerly S.W. corner of Parker DLC 49.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.8 acres Lot 3 (SW1 NE1)
2.4 acres SW1 NE1, as projected within Wm. Parker DLC 49

T. 6 S., R. 1 W., W.M.

Section 7

Land on which water is to be used is part of that described as follows:

Beginning at the re-entrant corner on the south boundary line of D.L.C. of
William Parker, being claim No. 49, and being 62.91 chains West of S.E. corner of
said claim and running thence East on the South line of said claim 5 chains to the
division line of said claim; thence North on said division line 6.5 chains; thence
West 5 chains to a corner of said claim; thence continuing West a total distance
of 15 chains; thence South 6.05 chains; thence East 10 chains to the place of
beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
