## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That SAM MASTROIENT

of 5618 S.E. 65th Ave., Portland , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Tualatin River

a tributary of Willamette River irrigation of 2.7 acres

for the purpose of

under Permit No. 25565 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 6, 1958

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.03 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NET SET, Section 20, T. 2 S., R. 1 E., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.7 acres NE4 SE2 Section 20 T. 2 S., R. 1 E., W.M.

Land on which water is to be used is part of that described as follows:

Beginning at the Southwest corner of the Southeast quarter of the Northeast quarter of Section 20, T. 2 S., R. 1 E.; thence South 00° 30° East a distance of 373.5 feet to a point which is 5 feet North 55° West from an iron pipe; thence 5 feet to said pipe; thence North 76° 30° East 519.8 feet to the Southwesterly corner of that certain tract conveyed to Emil Isaacson et ux by deed recorded April 24, 1945 in Book 343, page 10; thence North 235 feet, along the Westerly line of said Isaacson tract to the Southerly line of the Southeast quarter of the Northeast quarter of said Section 20; thence West on said line to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
