CERTIFICATE OF WATER RIGHT

This Is to Certify, That HARRY M. MCKER

of Rt. 1, Box 107-A, Gold Hill , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rogue River

a tributary of Pacific Ocean

for the purpose of

irrigation

under Permit No. 26083 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 23, 1959

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the Lot 2 (SH\dagger SE\dagger), Section 17, T. 36 S., R. 3 W., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 42 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.7 acre Lot 2 (SW4 SE4) Section 17 T. 36 S., R. 3 W., W.M.

Land on which water is to be used is part of that described as follows:

Beginning at the soughwest corner of Government Lot No. 2 in Section 17,
Township 36 South, Range 3 West of the Willamette Meridian in Jackson County,
Oregon, said point being also the quarter corner of the south line of said Section
17; running thence East on the said south line of Section 17, 925 feet for the
point of beginning; thence North 803.6 feet to the south bank of the Rogue River;
thence Northeasterly along the south bank of Rogue River 100 feet more or less;
thence South, parallel with the north and south center line of said Section 17,
827.1 feet to the south line of Section 17; thence West along said south line of
Section 17, 100 feet to the place of beginning; the said tract being also known
as Lot 17 of the Sleepy Hollow Tract, unrecorded.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
