## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That RAYMOND E. KERR

of 2020 River Rd., Eugene, , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well, consisting of five holes manifolded to a single pump a tributary of Middle Fork Willamette River for the purpose of irrigation of 52.1 acres

under Permit No. G-576 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 29, 1957

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.65 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW1 SW1, Section 15; SE1 SE1, Section 16, all as projected within Callison DLC 73, T. 18 S., R. 2 W., W.M. 4 holes are 2100 ft. S. & between points 775 ft. E. & 1250 ft. E., and 1 hole 2225 ft. S. & 1150 ft. E., all from NW corner DLC 73.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feat per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
