**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That WALTER CARL ADERS**

of Rt. 1, Box 38, Newberg, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of unnamed stream & reservoir constructed under Appl. #R-31085, Permit #R-1929 a tributary of Chehalem Creek for the purpose of irrigation of 11.3 acres

under Permit No. 24467 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 31, 1956

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.14 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$  NE $\frac{1}{4}$ , as projected within Morris DIC 46, Section 7, T. 3 S., R. 2 W., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-1929,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.5 acres NW $\frac{1}{4}$  NE $\frac{1}{4}$   
3.3 acres SW $\frac{1}{4}$  NE $\frac{1}{4}$   
1.5 acres NE $\frac{1}{4}$  NW $\frac{1}{4}$   
1.0 acre SE $\frac{1}{4}$  NW $\frac{1}{4}$

as projected within Morris DIC 46  
Section 7

T. 3 S., R. 2 W., W.M.

Land on which water is to be used is part of that described as follows:

Beginning at a point in the center of a County Road South 687 ft. and North 89° East 641 ft. from the Northwest corner of the Morris DIC 46; thence North 86°20' East along the center of said County Road 679 ft.; thence South 751 ft.; thence South 86° 20' West 679 ft. to an iron pipe in the bottom of a ditch; thence North 751 ft. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
