CERTIFICATE OF WATER RIGHT

This Is to Certify, That STANLEY MALOTT

of **Rt. 2, Box 148, McMinnville**, State of **Oregon**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **Yamhill River** a tributary of **Willamette River** for the purpose of **irrigation of 25 acres**

under Permit No. **25379** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **March 7, 1958**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.31 cubic foot per second**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **NE $\frac{1}{4}$ NE $\frac{1}{4}$** , as projected within Bird DLC 50, Section **14, T. 4 S., R. 4 W., W.M.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$ acre feet per acre** for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

9.0 acres **NW $\frac{1}{4}$ NW $\frac{1}{4}$** , as projected within Hawn DLC 51
1.5 acres **NW $\frac{1}{4}$ NW $\frac{1}{4}$** , as projected within Bird DLC 50
2.4 acres Lot 1 (**NW $\frac{1}{4}$ NW $\frac{1}{4}$**)
2.2 acres **NW $\frac{1}{4}$ NW $\frac{1}{4}$** , as projected within Watt DLC 78
0.5 acre Lot 1 (**SW $\frac{1}{4}$ NW $\frac{1}{4}$**)
0.6 acre **SW $\frac{1}{4}$ NW $\frac{1}{4}$** , as projected within Jesse DLC 79
2.5 acres **SW $\frac{1}{4}$ NW $\frac{1}{4}$** , as projected within Watt DLC 78
Section 13
6.3 acres **NE $\frac{1}{4}$ NE $\frac{1}{4}$** , as projected within Bird DLC 50
Section 14
T. 4 S., R. 4 W., W.M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
