CERTIFICATE OF WATER RIGHT

This Is to Certify, That JOHN H. BOYD

of Rt. 2, Box 217 A., Aurora, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Willamette River a tributary of _____ for the purpose of irrigation of 1.2 acres

under Permit No. 24343 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 16, 1956

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.02 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 29, T. 3 S., R. 1 W., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.1 acre SW $\frac{1}{4}$ SE $\frac{1}{4}$
0.5 acre SE $\frac{1}{4}$ SE $\frac{1}{4}$
0.6 acre SE $\frac{1}{4}$ SE $\frac{1}{4}$ as projected within A. Cone DLC 48
Section 29
T. 3 S., R. 1 W., W.M.

Land on which water is to be used is part of that described as follows:

Beginning at an iron pipe in the center line of County Road #178 which is West 624.36 ft. and North 656.04 ft. and West 642.22 ft. from the corner common to Sections 28, 29, 32, 33, T. 3 S., R. 1 W., of W.M.; thence North 48° 34' East along Center Line of said County Road 301.67 ft. to an iron pipe; thence North 40° 26' West 240.00 ft. more or less to the Right Bank of the Willamette River; thence upstream following the meanders of River to point due West from the point of beginning; thence East to point of Beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
