## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That MARK KRYSTO

of Nerlin , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rogus River and 2 springs
a tributary of for the purpose of

irrigation of 1 acre and domestic use 1 family

under Permit No. 17691 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from Jamery 13, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.02 cubic foot per second, being 0.01 c.f.s. for domestic & 0.01 c.f.s. for irrigation water to be diverted from springs for irrigation when available & any deficiency in available supply from springs to be made up by diversion from river, or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the Lot 2 (SWI NWI), Section 19, T. 34 S., R. 7 W., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $4\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year, provided further that the amount of water allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed the limitation allowed herein, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Domestic and 1 acre Lot 2 (SW1 NW1)
Section 19
T. 34 S., R. 7 W., W.M.

Land on which water is to be used is part of that described as follows:

Beginning at Corner #3, a monumented point on Survey No. 863 in Lot #2, Section 19, T. 34 S., R. 7 W., W.M., thence North 25° 46' E. true bearing for a distance of 60 ft. to the point of beginning, thence due West approximately 170' to River Road; thence N.E. on East side of said road for a distance of 510 ft.; thence due East a distance of 160 ft.; thence S. 25° 46' W., for a distance of 510' to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
