**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That RALPH D. STOUTENBURG**

of Rt. 1, Dayton, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Lambert Slough a tributary of Willamette River for the purpose of irrigation of 42.2 acres

under Permit No. 24168 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 29, 1956

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.53 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 1 (NE $\frac{1}{4}$  NE $\frac{1}{4}$ ), Section 21, T. 5 S., R. 3 W., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

15.0 acres NE $\frac{1}{4}$  NE $\frac{1}{4}$   
12.9 acres NW $\frac{1}{4}$  NE $\frac{1}{4}$   
8.3 acres SW $\frac{1}{4}$  NE $\frac{1}{4}$   
6.0 acres SE $\frac{1}{4}$  NE $\frac{1}{4}$   
as projected within Angell DLC 57  
Section 21  
T. 5 S., R. 3 W., W.M.

Land on which water is to be used is part of that described as follows:

Beginning at an iron pipe set on the East line of and South 6.81 chains from the Northeast corner of DLC 57; thence South along the East line of said Claim 15.43 chains to iron pipe set for the S.E. Corner of the North  $\frac{1}{2}$  of said Claim; thence Westerly along division line of claim 32.053 chains, more or less, to the center of the County Road now there; thence Northerly along the center of said county road 15.62 chains, more or less, to iron pipe set for S.W. corner of County Survey No. 2168 $\frac{1}{2}$ ; thence North 90 degrees East with line of said County Survey 2168 $\frac{1}{2}$ , 30.346 chains to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
