## CERTIFICATE OF WATER RIGHT

(For rights perfected under original, enlargement or secondary permits)

This is to Certify, That Howard H. CAMP
of Harper . State of Oregon , has made proof
to the satisfaction of the STATE WATER BOARD of Oregon, of a right to the use of the
waters of Malheur River , a tributory of Snake River
, for the purpose of the irrigation of 35 acres of land
under Permit No.2659 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon and duly confirmed by order of the STATE WATER BOARD of Oregon, made and entered
of record in the Record of Proceedings of said Board, at Salem, in Volume 1 ,
ut page 368 , on the 17th - day of November, 1920 ; that the priority of
the right hereby confirmed dutes from October 22, 1915 ; that the amount of
water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not
exceed 0.44 cubic feet per second, or its equivalent in case of rotation. The use under shall conform to any reasonable rotation system ordered by the proper State Office A description of the lands under such right, and to which the water hereby
to beneficial use, is as follows: 5 acres in the Northwest quarter of Northeast quarter 15 acres in the Southwest quarter of Northeast quarter; 9 acres in the Northwest quarter of Southeast quarter and 6 acres in the Northeast quarter of Southwest quarter of Section Twenty-three, Township Twenty South, Range Forty-one East of Willamette Meridian, in Malheur County, Oregon.

Rights to the use of water for power purposes are limited to a period of forty years from the date of priority of the right, as herein set forth, subject to a preference right of renewal under the laws existing at the date of the expiration of the right for power purposes, as hereby confirmed and limited.
