under Permit No. 16393 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 3, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 4.79 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE4 NE4, NE4 NW4, Section 12, T. 2 N., R. 30 E., W.M.; NW4 SW4, SW4, SW4, Section 7; NE4 NW4, Section 18; T. 2 N., R. 31 E., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fourtieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed by acre feet per acre for each acre irrigated during the irrigation season of each year, and shall be subject to contract No. li-06-100-1336 with the Bureau of Reclamation, a copy of which is on file in the office of the State Engineer,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
