CERTIFICATE OF WATER RIGHT

This Is To Certify, That U. S. DEPARTMENT of INTERIOR
FISH AND WILDLIFE SERVICE
BUREAU OF SPORT FISHERIES AND WILDLIFE

of Office of the Regional Director, P. O. Box 3737, Portland 8, State of Oregon, has a right to the use of DONNER AND BLITZEN RIVER for the purpose of IRRIGATION, DOMESTIC, STOCK AND MAINTENANCE OF KRUMBO RESERVOIR AS A WILDLIFE HABITAT AREA, and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for HARNEY County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 13, at page 508; that the priority of the right thereby confirmed dates from (SEE BELOW) that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed one-fortieth of a cubic foot per second per acre prior to June 15, and one-eightieth of a cubic foot per second per acre after June 15, with a total limitation of three acre feet per acre from March 15 to October 1, measured at the point of diversion from the stream.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:
