exceed 1.78 cubic feet per second, or its equivalent in case of rotation. The use nereunder shall conform to any reasonable rotation system ordered by the proper State Officer. A description of the lands under such right, and to which the water hereby confirmed is appartenant, or, if for other purposes, the place where such water is put to heneficial use, is as follows: 35.4 acres in the Southwest quarter of Southwest quarter; 40 acres in the Northwest quarter of Southwest quarter of Northwest quarter; 15 acres in the Southeast quarter of Northwest quarter; 11 acres in the Northeast quarter of Southwest quarter and 5 acres in the Southeast quarter of Southwest quarter of Southwest quarter of Thirty-three East of Willamette Meridian, in Grant County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.

Rights to the use of water for power purposes are limited to a period of forty years from the date of priority of the right, as herein set forth, subject to a preference right of renewal under the laws existing at the date of the expiration of the right for power purposes, as hereby confirmed and limited.
