CERTIFICATE OF WATER RIGHT

This Is to Certify, That ANTON PFAU JR.

of 1670 Labish Garden Road, Salem , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well

a tributary of Pudding River irrigation of 27.1 acres

for the purpose of

under Permit No. G-1010 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 9, 1958

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.33 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE¹/₄ Sw¹/₄, Section 13, T. 6 S., R. 2 W., W.M. Well is 550 ft. S. and 495 ft. W. from center of 13.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.6 acres SE NN 2 23.5 acres NE SW 2 Section 13 T. 6 S., R. 2 W., W.M.

Land on which water is to be used is part of that described as follows:

Beginning at the center of Section 13, Township 6 South, Range 2 West of the Willamette Meridian in Marion County, Oregon; thence North on the legal subdivision line, 9 chains and 26 links; thence West 4 chains and 50 links; thence South on the East boundary of land formerly owned by Henry Epley, 10 chains; thence South 36 deg. 15' West 21 chains and 26 links to the Northwest corner of a 40 acre tract of land deeded by George W. Weeks to Anton Wolki; thence South 48 deg. East in the middle of the county road, 4 chains and 17 links; thence North 83 deg. East continuing in the middle of said road, 15.30 chains to the legal subdivision line running through the center of said section 13; thence North on said line 19.21 chains to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
