CERTIFICATE OF WATER RIGHT

This Is to Certify, That JACKSON COUNTY

of Jackson County Court House, Medford, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of County wells Numbers 3, 4, and 5

a tributary of Jackson Creek (Bear Creek)

for the purpose of supplemental irrigation

under Permit No. G-1216 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 24, 1959

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.02 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE₄¹ SE₄¹, as projected within Welton DLC 67, Section 21, T. 37 S., R. 2 W., W.M. #3 is 3330 ft. S. & 350 ft. E., #4 is 3230 ft. S. & 350 ft. E., #5 is 3155 ft. S. & 350 ft. E., all from NE corner, Miller DLC 41

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
