**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** **DELMAR J. STORMENT**

of Rt. 2, Box 391-B, Eugene, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well

a tributary of McKenzie River  
irrigation

for the purpose of

under Permit No. G-903 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 26, 1958

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.03 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 31, T. 16 S., R. 3 W., W.M. Well is 1 $\frac{1}{2}$  chain S. and 5 $\frac{1}{2}$  chains E. from the N $\frac{1}{2}$  corner, Section 31.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.1 acres NW $\frac{1}{4}$  SE $\frac{1}{4}$   
Section 31  
T. 16 S., R. 3 W., W.M.

Land on which water is to be used is part of that described as follows:

Beginning at a point on the North line of Section 31, Township 16 South, Range 3 West, of the Willamette Meridian, South 89° 45' East 176.2 ft. from the  $\frac{1}{4}$  corner on the North side of said Section; and running thence along said Section line South 89° 45' East 446.2 ft. to a point on the bank of a slough; thence South 210.0 ft.; thence North 89° 45' West 446.2 ft.; thence North 210.0 ft. to the point of beginning; in Lane County Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
