a tributary of McKenzie River irrigation of 61.4 acres

for the purpose of

of the State Engineer, and that said right to the use of said waters 24349 under Permit No. has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 19, 1956

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.47 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 1 (SE4 NW4), Section 3, T. 17 S., R. 2 W., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is part of that described as follows:

Beginning at a point on the West line of the Conation Land Claim No. 63, in

Township 17 South, Range 2 West, W.M., 17.25 chains South of the Northwest corner
of said claim, running thence east 48.83 chains to the East line of said claim,
thence South 16.64 chains, thence West 48.83 chains, thence North 16.64 chains to the place of beginning, except a tract deeded to Southern Pacific Company by Deed recorded in Volume 17, page 507, Lane County Oregon Deed Records, and except that part lying North and West of said Right of Hay.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
