## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That SAM & OPAL LOONEY

of 1208 Oak St., Albany , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Looney Well #1

a tributary of Santiam River irrigation of 36 acres

for the purpose of

under Permit No. G-538 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 26, 1957

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.15 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW1 NW1, as projected within Clelen DIC 77, Section 3. T. 11 S., R. 2 W., W.M. Well is 920 ft. South and 90 ft. East from N.W. corner, Section 3.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

18.2 acres NW M NV as projected within Clelen DIC 47
17.8 acres NE NV as projected within Clelen DIC 47
Section 3
T. 11 S., R. 2 W., W.M.

Land on which water is to be used is part of that described as follows:

Part of the Robert Clelen Claim 77 in T. 11 S., R. 2 W. of the Willamette
Meridian described as: Beginning at an iron pipe on the West line of and South
9.63 chains distant from the Northwest corner of Section 3, in said T. and R.;
thence South 9.87 chains to an iron pipe; thence East 39.90 chains to a stone
marked CS on the East line of the Northwest quarter of said Section; thence
North 9.87 chains to a point which is South 9.75 chains distant from the Northeast
corner of the Northwest quarter of said Section; thence West 39.90 chains to the
place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
