a tributary of Deschutes River irrigation of 21.55 acres

for the purpose of

under Permit No. 27307 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 31, 1961,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.43 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE SW1, Section 26, 2. 14 S., R. 10 E., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fiftieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed he acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

## CERTIFICATE OF WATER RIGHT

for the purpose of Stock use from Alder Creek and Zumwalt Creek and stock and domestic use through pipe line from unnamed spring,

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Marion County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 14, at page 354; that the priority of the right thereby confirmed dates from 1880 for stock and domestic use from unnamed spring; and is subject to the provisions of Paragraph 165 of said decree;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.03 cubic foot per second from unnamed spring; and shall be subject to the provisions of Paragraph 165 of said decree.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

Stock use from Alder Creek and Zumwalt Creek:

Beginning at an angle corner on the south line of the donation land claim of A. R. Miller in Tp. 9 S., R. 1 E., W.M., in Marion County, Oregon, said point being also the northeast corner of the Henry J. Sumwalt D. L. C.; thence south 3° east 58 chains to the section line between Secs. 8 and 17, in said township and range; thence west 35.03 chains on line between Secs. 7, 8, 17, and 18; thence north 57.92 chains to the south line of the D. L. C. of said A. R. Miller; thence east 32.01 chains to the place of beginning and containing 194.20 acres of land, more or less, subject to a right-of-way 20 feet wide along the east boundary line as set forth in a deed, Volume 131, Page 217, and excepting about  $1\frac{1}{2}$  acres conveyed to Alois Imper.

Also all of Lot 3 in Sec. 17, Tp. 9 S., R. 1 E., W.M.; also commencing at the northwest corner of said Lot 3; thence north 4 rods; thence west 4 rods; thence south to the south line of Lot 1 in Sec. 18 and parallel with the west line of said Lot 3; thence east to the west line of Lot 3; thence north on the west line of Lot 3 to the place of beginning, all in Tp. 9 S., R. 1 E., W. M., in Marion County, Oregon.

Also a right-of-way 20 feet wide along the east and north lines of said Lot 1

as set forth in a deed in Volume 94, Page 179.

Also beginning 10 chains west from the northeast corner of Sec. 18 in Tp. 9 S., R. 1 E., W. M., in Marion County, Oregon; thence south 1½ chains; thence west 10 chains parallel with the north line of said Sec. 18 to the west line of Lot 1; thence north 1½ chains to the north line of said Sec. 18; thence east on said line 10 chains to the place of beginning containing 1½ acres of land.

Also Lot 1 in Sec. 18, Tp. 9 S., R. 1 E., W. M., in Marion County, Oregon, containing 52 acres, more or less, excepting a road on the east line of same, and also excepting 7 acres lying along the south side of said property, previously deeded to

A. L. Schreve.

Stock and Domestic use from Unnamed Spring SEISEI, Section 7 and Lot 3, Section 8
T. 9 S., R. 1 E., W.M.

And said right shall be subject to all other conditions and limitations contained in said decree.
