CERTIFICATE OF WATER RIGHT

This Is to Certify, That WENDELL G. HILL

of P. O. Box 506, Scappoose , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of unnamed stream and reservoir constructed under Application No. R-32773, Permit No. R-2202

a tributary of Willamette Slough irrigation of 1.08 acres

for the purpose of.

under Permit No. 25862 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 24, 1958

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE_4^1 $SW_{4,9}^1$ as projected within Jackson DLC hh, Section 2h, T. 3 N., R. 2 W., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-2202,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.70 acre NW4 SW4
0.38 acre NE4 SW4
as projected within Jackson DLC lilith Section 2h
T. 3 N., R. 2 W., W.M.

Land on which water is to be used is part of that described as follows:

The westerly 200 ft. of the following described property. Beginning at a point which is the SE corner of the Leonard Estate tract; said point being N. 20° 05' E. 235.48 ft. from the SW corner of the T. J. Jackson DIC and on the W. line of said Jackson DIC in Section 24, T. 3 N., R. 2 W.; thence along the S. line of that property described in Book 64, page 136, S. 70° 20' E. a distance of 997.98 ft.; thence N. 20° 01' E. a distance of 237.50 ft. to the N. line of said property described in Book 64, page 136; thence N. 70° 28' W. a distance of 997.57 ft. to the W. line of Said Jackson DLC; thence S. 20° 05' W. a distance of 235.48 ft. to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
