CERTIFICATE OF WATER RIGHT

This I to Certify, That ROY E. LANGLEY

of 3003 N. E. Douglas St., Roseburg , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Deer Creek

a tributary of S. Umpqua River irrigation of O.6 acre

for the purpose of

under Permit No. 23844 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 18, 1955

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW_4^1 NE $_4^1$, as projected within Stephens DIC lio, Section 20, T. 27 S., R. 5 W., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.6 acre SW4 NE4 as projected within Stephens DLC 40 Section 20

T. 27 S., R. 5 W., W.M.

Land on which water is to be used is part of that described as follows:

Starting at a fence corner on the South side of a county road, and at a point which is S. 89° 44. W. 6.75 chs. from the NE corner of the Thomas Stephens DIC 40, T. 27 S., R. 5 W., W.M.; which is also S. 89° 44. W. 154.0 ft. from a 1½ inch iron pipe which marks the N. W. corner of the Ralph W. Clark property, thence continuing westerly along the S. right-of-way line of said county road a distance of 203.23 ft. which location is the beginning point of this land to be conveyed; thence extending South from this beginning point a distance of 346.0 ft. to the center of Deer Creek; thence S. 65° 44. W. a distance of 80 ft., along the center of said creek downstream, to a point; thence North 22.5 ft. to a 3/4 inch iron bar; thence continuing N. 323.5 ft. to a 1/2 inch iron pipe on the South right-of-way line of said county road; thence N. 89° 44. E. 80 ft. along said right-of-way line, to the place of beginning, all of the above is situated in the N. E. 4 of section 20, T. 27 S., R. 5 W. W.M., Douglas County, Oregon.
