of 2580 Harvest Lane, Springfield , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of unnamed slough

a tributary of McKenzie River irrigation of 11.0 acres

for the purpose of

under Permit No. 25446 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 15, 1958

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **C.ll.** cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE4 SE4, as projected within Spencer DIC 50, Section 23, T. 17 S., R. 3 W., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

8.0 acres NE 4 SE 4
3.0 acres SE 4 SE 4
as projected within Spencer DLC 50
Section 23
T. 17 S., R. 3 W., W.M.

Land on which water is to be used is part of that described as follows:

Beginning at a point 208.6 feet East and 916.8 feet North of the corner to
Sections 23, 24, 25, and 26, Township 17 South, Range 3 West, Willamette Meridian;
thence West 715 feet; thence South 72 feet; thence West 420.8 feet; thence North
0 degrees 53' East 1416 feet; thence North 74 degrees 00' East 567.0 feet; thence
South 00 degrees 53' West 1391.9 feet; thence East 588.2 feet; thence South
00 degrees 53' West 100 feet to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
