CERTIFICATE OF WATER RIGHT

This Is to Certify, That J. B. MANSUR

of **BB Rt., Box 475, Cottage Grove**, State of **Oregon**, has made proof to the satisfaction of the **STATE ENGINEER** of Oregon, of a right to the use of the waters of **Alder Creek**

a tributary of **Coast Fork River**
irrigation of **0.8 acre**

for the purpose of

under Permit No. **25734** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **September 3, 1958**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.01 cubic foot per second**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **SW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 5, T. 23 S., R. 3 W., W.M.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,**

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

**0.1 acre NW $\frac{1}{4}$ NE $\frac{1}{4}$
0.7 acre SW $\frac{1}{4}$ NE $\frac{1}{4}$

Land on which water is to be used is part of that described as follows:

Description of the tract of land the title to which is insured by this Policy.

Beginning at a point in the center of County Road No. 351, said point being **S. 1356.0 ft. and E. 647.0 ft.** from the one quarter corner on the N. line of Section 5, T. 23 S., R. 3 W., W.M., thence **N. 74° 55' E. 672.8 ft.** to an iron pin in the existing fence line; thence **S. 0° 04' E. along said fence, 437.4 ft.** to an iron pin in the Northerly line of a 16' gateway, (granted in the Circuit Court of Lane County, Ore., in the case of Combs vs Geer, Aug. 5, 1921); thence **S. 74° 55' W. along the Northerly line of said gateway, 350.0 ft.** to the center of said Road, thence **Northerly along the center of said Road, North 37° 55' W. 178.2 ft.** and **N. 43° 36' W. 293.8 ft.** to the point of beginning, in said Section 5, in Lane County, Oregon

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
