CERTIFICATE OF WATER RIGHT

This Is to Certify, That HAROLD NEISON

of P. J. Box 706, Corvallis , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Willamette River

a tributary of Columbia River irrigation of 1 acre

for the purpose of

under Permit No. 24908 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from Kay 14, 1957

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE¹₄ SE¹₄, as projected within Moore DIC 66, Section 35, T. 11 S., R. 5 W., WM.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

l acre SE¹/₄ SE¹/₄ as projected within Moore DLC 66 Section 35

T. 11 S., R. 5 W., W.M.
Land on which water is to be used is part of that described as follows:

Beginning at a 1" pipe on the E. line of the Fred Blumhart tract as described in deed recorded March 18, 1919 in Book 11h, page 586, Deed Records, in Isaac Moore DIC #66 in Section 35, T. 11 S., R. 5 W., W.M., which tract was deeded to Benton County by deed recorded in Book 69, page 30h, Deed Records, which pipe is 132.7 feet S. 21° 08' W. of the N.E. corner of said tract and which pipe is also 70h.1 ft. E. and 187 ft. S. of a pipe set for the N.E. corner of Joseph C. Avery DLC #51 said township and range; thence S. 21° 08' W. along the East line of said tract 167.5 ft. to a 1½" pipe at the fence, the S.E. corner of said Blumnart tract; thence N. 69° 49' W. 300 ft. to a low water mark on the Willamette River, which point is 43.93 ft. North 69° 49' W. of a 1½" iron rod; thence with the meanderings of said stream M. 21° 08' E. 153.23 ft. to a point 48.56 ft. N. 72° 30' W. of a 1" iron rod; thence S. 72° 30' E. 300.56 ft. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
