This Is to Certify, That ROBERT A. SMITH

of 1205 Fletcher Road, Salem , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well

a tributary of Pudding River irrigation of 10 acres

for the purpose of

of the State Engineer, and that said right to the use of said waters under Permit No. G-969 has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 29, 1958

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.12 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Wi NE . As projected within Martin DIC 71, Section 8, T. 7 S., R. 2 W., W.M.; Well is 1450 ft. N. and 180 ft. W. from S. E. corner. DIG 71.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.0 acres NE W 5.3 acres NW 4 NE

2.1 acres SW2 NE 0.6 acre SEE NW 1

as projected within J. Martin DIC 71

Land on which water is to be used is part of that described as follows: Beginning at an iron bar in the East line of the Martin DLC 71, 22.01 chains from the Southeast corner of said claim in T. 7 S., R. 2 W., W.M.; thence North 89° 21' W. 12.44 chs. to an iron pipe; thence N. 6' W., 5.91 chs. to an iron pipe; thence S. 72° 17' E. 13.40 chs. to the E. line of said claim; thence S. 9° W. along said E. line, 2 chs. to the point of beginning; also, beginning at a point on the E. line of the Martin DIC 71, 16.97 chs. N. 9 E. from the SE corner of said claim; thence N. 9° E. 5.04 chs. along the E. line of the said DLC; thence N. 89° 21' W., 12.41 chs. parallel to the S. line of a 21.65 acre tract, to the W. line of said tract; thence S. 0° 06' E., 5.00 chs., along the W. line of said 21.65 acre tract to the SW corner of of the same; thence S. 89° 21' E., 11.63 chs. to the place of beginning. Save and except 1.00 acre sold off the S. side of the above described tract of land.
