## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That R. L. WALKER

Amity Rt. 1, , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of ummamed creek and reservoir constructed under Permit No. R-1407 and enlarged under Permit Nos. R-1560 and R-1761 a tributary of Chehalem River for the purpose of

irrigation of 140.2 acres and supplemental irrigation of 4.4 acres

under Permit No. 23676 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 21, 1954

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.80 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW1 SW1, NE1 SW1, as projected within Bean DIC 11, Section 2, T. 3 S., R. 3 W., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under permit number R-1407 and enlarged under permit nos. R-1560 and R-1761, and shall be still further limited to the use of stored water only on lands described as supplemental,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
