CERTIFICATE OF WATER RIGHT

This Is to Certify, That the CROOK COUNTY IMPROVEMENT DISTRICT No. 1

of Redmond, State of Oregon, has a right to the use of the waters of Deschutes River for the purpose of Irrigation

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Deschutes County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 12, at page 282; that the priority of the right thereby confirmed dates from October 31, 1900 for 29.1 cubic feet per second

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed the quantity determined by the duty of water as set by Decree of the Circuit Court for Deschutes County, dated March 24, 1933.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:
