## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That L. C. HERIZA

of 2239 9th St., Baker , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of 2 wells

a tributary of Powder River irrigation of 7.2 acres

for the purpose of

under Permit No. G-1106 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 13, 1958

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.09 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW2 NW2, Section 17, T. 9 S., R. 40 E., W.M. Well #1, Lot 1 Block 51; Well #2, Lot 1 Block 50 of Levins Addition to Baker

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

7.2 acres NW 4 NW 4 Section 17 T. 9 S., R. MO E., W.M.

Land on which water is to be used is part of that described as follows:

All of Blocks 50, 51 and 53 in and of B. W. Levens Second addition to Baker
City, Baker County, Ore., and all that portion of Block 52 in and of said B. W.
Levens Second Addition, lying E. of the right of way of the C.W.R.R. & N. Co. Also,
the following described premises: Commencing at the SE corner of Lot 1 in Block
53 of B. W. Levens Second Addition to Baker City, Baker County, Ore.; thence W.
along the S. line of Lot 1 and Lot 10 in said Block 53 to the SW corner of said
Lot 10; thence SE along the E. line of Railroad Street to the NW corner of Lot 5
in Block 52 of said B. W. Levens Second Addition; thence E. along the N. line of
said Lot 5 to the NE corner of said Lot 5; thence N. to the place of beginning.
Commencing at the NW corner of Lot 5 in Block 53 of said B. W. Levens Second Addition, thence W. to the NE corner of Lot 6 in said Block 53, thence S. to the
SE corner of Lot 10 in said Block 53; thence E. to the SW corner of Lot 1 in said
Block 53, thence N. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
