CERTIFICATE OF WATER RIGHT

This Is to Certify, That AMBROSE CALCAGNO

of 4201 S.E. Lake Rd., Milwaukee 22, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well

a tributary of none
irrigation of 7.5 acres

for the purpose of

under Permit No. G-251 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 22, 1956

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.09 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within Garrett DLC 38, Section 31, T. 1 S., R. 2 E., W.M.; Well is 640 ft. N. and 160 ft. E. from S.W. corner, Section 31.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows: 2 acres SE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within Kellogg DLC 67

4.2 acres SW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within Garrett DLC 38

1.3 acres SW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within Kellogg DLC 39

Land on which water is to be used is part of that described as follows:

Part of the John D. Garrett DLC 38 in Section 31, T. 1S., R. 2E., W.M., and part of the Joseph Kellogg DLC 67 in Section 36, T. 1S., R. 1E., W.M., and #39 in Section 31, T. 1S., R. 2E., W.M., described as: Beginning at a stone with a brass screw placed on top, which stone is N. 0° 51' W. 32.4 ft. from the SW corner of that certain tract of land conveyed by William Atkinson et al to Daniel McLaren, by deed recorded in book 29 at page 600, records of Clackamas County, Oregon, and which beginning point is on the N. boundary of Lake Road; thence N. 0° 51' W. along the W. line of said Daniel McLaren land 1095.7 ft. to an iron pipe on the southerly right of way line of the Portland and Oregon City Railway; thence S. 57° 21' E. 358.86 ft. along the southerly line of said right of way to an iron pipe set at the NW corner of a tract of land conveyed to Lester Wright and Ruth Wright, by deed recorded Jan. 13, 1932 in book 214, page 280 deed records, aforesaid; thence S. 0° 7' E. along the W. line of said Wright land 1046.2 ft. to the center of Lake Rd.; thence N. 68° 40' W. along center line of road 307.8 ft. to a point thence N. 0° 51' W. 32.4 ft. to beginning point. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
