This Is to Certify, That ROBERT A. ALBERTUS

of Rt. 1, Box LOL, Coos Bay , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Unnamed Creek

a tributary of Isthmus Slough domestic use one family

for the purpose of

under Permit No. 23386 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 25, 1955

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 8 (SW 1_4 SW 1_2), Section 23, T. 26 S., R. 13 W., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to - - - - - - of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is

appurtenant, is as follows: Domestic

Lot 8 $(SW_{\frac{1}{4}}^1 SW_{\frac{1}{4}}^1)$

Section 23 T. 26 S., R. 13 W., WaM.

Land on which water is to be used is part of that described as follows:

Beginning at an iron post which marks the intersection of the westerly right of way line of the Oregon Coast Highway 101 and the Northerly right of way line of Southport Creek Road, said iron post bears N. 60°-18:-27" E.999.7 ft. from the corner common to sections 22, 23, 27 and 26 in T. 26 S., R. 13 W., W.M., thence N. 69°-03' W. 83.81 ft. along said northerly right of way line of Southport Creek Road to an iron post thence N. 59°-28' W. 271.19 ft. along aforementioned Northerly R/W line to an iron post, thence N. 147°-04' W. 76.74 ft. along said northerly right of way line to an iron post, thence N. 68°-15' E. 349.31 ft. to an iron post, thence S. 48°-45' E. 238.32 ft. to an iron post on the westerly right of way line of the Oregon Coast Highway 101, thence Southwesterly along said westerly right of way line of the Oregon Coast Highway 101 for a distance of 209.0 ft., more or less to the point of beginning, containing 2.1 acres, more or less all being within Lot 8, Sec. 23 T. 26 S., R. 13 W., W.M., County of Coos, State of Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
