## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That BEN YEIK

of Rt. 1, Box 902 B, Coos Bay , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of unnamed Creek

"tributary of coal bank slough - Coos Bay consetic use for 1 family and irrigation

for the purpose of

under Permit No. 21601 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 7, 1957

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.02 cubic foot per second being 0.01 cubic foot per second for irrigation

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NET NET as projected within Flanigan DIC 40, Section 9, T. 26 S., R. 13 W., W. H.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightietle one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each some irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is part of that described as follows:

Beginning 20.0 ft. N. from the quarter quarter section line at a point 210.0 ft. W from the SE corner of the NEt of the NEt of Section 9 of T. 26 S., R. 13 W., W.M., Coos County, Oregon; thence running N. 1° 11' W. parallel with the section line 631.3 ft.; thence E. 210.0 ft. to the section line; thence S. 1° 11' E., along the rection line 573.3 ft.; thence W. 20.0 ft.; thence S. 1° 11' E. 58.0 ft., more or less, to a point 20.0 ft. N. of the quarter quarter section line; thence W. parallel with said line 190.0 ft. to the place of beginning. Located in the NEt of the NEt of Section 9 of said Coos County Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
