CERTIFICATE OF WATER RIGHT

This Is to Certify, That ALBERT & JUANITA STRAIN

of 930 N.E. Brooklyn Ave., Roseburg , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Unnamed stream

a tributary of South Umpqua River irrigation of 0.5 acre

for the purpose of

under Permit No. 24998 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 5, 1957

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW_{4}^{1} SW_{4}^{1} , as projected within S. C. Braden DLC 37, Section 7, T. 27 S., R. 5 W., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{6}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.5 acre $SW_{\frac{1}{4}}^{\frac{1}{4}}SW_{\frac{1}{4}}^{\frac{1}{4}}$ as projected within Braden D L C 37 Section 7 T. 27 S., R. 5 W., W.M.

Land on which water is to be used is part of that described as follows:

The W2 of the following described property, to-wit: Beginning at the Southeast corner of Lot 17, Fruitvale Addition to the City of Roseburg, Oregon; thence North along the East line of said Lot 17, Fruitvale Addition, a distance of 172 feet; thence Westerly and parallel with the South line of said Lot 17, Fruitvale Addition a distance of 251 feet; thence Southerly and parallel with the East line of said Lot 17, Fruitvale Addition 172 feet; to the South line of said Lot 17; thence Easterly along the South line of Lot 17, Fruitvale Addition, a distance of 251 feet to the place of beginning, Douglas County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
