CERTIFICATE OF WATER RIGHT

This Is to Certify, That WILLIAM L. PAINTER

of P. O. Box 17, Dillard , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Umpqua River

a tributary of Umpqua River irrigation of 3.0 acres

for the purpose of

under Permit No. 251113 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 11, 1958

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.04 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW_2^1 NE_{49}^1 Section 3, T. 29 S., R. 6 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.66 acres NW NE 1 0.34 acre SW NE 1 Section 3 T. 29 S., R. 6 W., W. M.

Land on which water is to be used is part of that described as follows:

Beginning at a 3/4 inch iron pipe on the S. right of way line of the Pacific Highway which is 5.0° 25' E. 835.3 ft. and S. 71° 26' 30" E. 407 ft. from the NE corner of the Robert Phipps DLG 37 in T. 29 S., R. 6 W., W.M., thence along the S. line of said Highway S. 71° 26' 30" E. 118.4 ft. and S. 77° 34' 30" E. 202.8 ft. to a 1/2 inch iron bar; thence S. ?° 11' 30" E. 331.2 ft. to a 1/2 inch iron rod on the N. line of tract of the State of Oregon described in deed recorded in Volume 101, page 2, Deed Records of Douglas County; thence S. 75° 44 W. 252.0 ft. along the N. line of said tract to a 1/2 inch iron rod; thence N. 85° 36' 30" W. 90.4 ft. to a 1/2 inch iron pipe; thence N. 0° 43' 30" E. 467.2 ft. to the place of beginning, in the Wa NE 2, Section 3, T. 29 S., R. 6 W., W. M., Douglas County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
