CERTIFICATE OF WATER RIGHT

This Is to Certify, That EDWARD E. SIMONS

of Rt. 4, Box 181-A, Eugene, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Bear Creek & Coast Fork Willamette River

a tributary of Coast Fork Willamette River for the purpose of irrigation of 33.4 acres

under Permit No. 23567 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 27, 1955

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.42 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within Callison DIC 50, Section 6, T. 19 S., R. 2 W., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year; water to be diverted from Bear Creek when available and any deficiency in Bear Creek is to be made up by diversion from Coast Fork Willamette River providing that the total quantity diverted from both streams shall not exceed 1/80th c.f.s. for each acre irrigated.

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
