## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That DONALD J. & ALICE O. SELLON

of Rt. 1 Box 227, Albany, , State of Cregon, , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well

a tributary of Cox Creek

for the purpose of

irrigation of 33.8 acres

under Permit No. G-1128 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 13, 1958

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.32 cubic foot per second** 

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the Lot 4 (SH NE4) Section 10, T. 11 S., R. 3 W., W.M. Well 18 S. 9° 20° R. 30.5 chains from N. 4 corner, Section 10.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

24.8 acres Lot 4 (SW 1 NE 1)

9:0 acres Lot 3 (SE Net ) Section 10

T. 11 S., R. 3 W., W.M.

Land on which water is to be used is part of that described as follows: That part of the following described land lying north of the County Road. Beginning at the SE corner of the Donation Land Claim of Hugh Nickerson and wife, same being Notification N. 708 and Claim No. 39 in Township 11 S., Range 3 W. of the Willamette Meridian, Oregon, and running thence W. 10.44 chains; thence S. 13.54 chains, to the center of the County Road, thence N. 88° E. 5.94 chains, thence S. 4.88 chains to the N. boundary line of the Donation Land Claim of C. P. Burkhart, same being Notifi-NO. 695 and Claim No. 46 in said Township and Range, thence E. 26.70 chains, to the NE corner of said Claim No. 46, thence N. 5.50 chains to the center of the County Road, thence S. 88° W. 3.70 chains, to the East boundary line of Lot No. 4 of Section 10 in said Township and Range, thence N. 12.94 chains to a point due E. of the place of beginning, and thence W. 18.49 chains to the place of beginning, containing 19.82 acres, more or less, all lying and being in the County of Linn and State of Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
