of Rt. 1, Box 1, Brooks , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well.

a tributary of Willamette River irrigation of 2.7 acres

for the purpose of

under Permit No. G-817 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from Hay 9, 1958

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.03 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NR SW1, as projected within Brooks DIC 61, Section 17, T. 6 S., R. 2 W., W.M. Well is 23 chains S. & 50.7 chains E. from M. corner DIC 61.

IN corner DIC 61.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per sore for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.7 acres NET SWT, as projected within Brooks DIC 64 Section 17

T. 6 S., R. 2 W., W.M.

Land on which water is to be used is part of that described as follows:

Deginning in the center of the County Road, at a point which is 20.50 chs.

Southerly along the W. boundry and 32.94 chs. S. 89° 26° E. and S. 980 ft. S. 89°

26° E. from the NW corner of the Limus Brooks DLC 64 in T. 6 S., R. 2 W., W.M., in Marion County, Oregon; thence S. 0° 54° W. 511.06 ft., thence E. 348.93 ft. to the Southerly line of land conveyed to A. M. Aspinwall by Harrison Jones and wife; thence N. 58° 40° W. 253.37 ft. to the most westerly corner of said Aspinwall tract; thence N. 31° 20° E. along the Northwesterly boundry of said Aspinwall tract; thence N. 31° 20° E. along the Road leading from Brooks to Wheatland; thence N. 60° 36° W. along the center of said Road 97.49 ft. to an iron pipe in said center line; thence N. 89° 26° W. along the center line of said Road 239.86 ft. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
