CERTIFICATE OF WATER RIGHT

This Is to Certify, That EDNA E. FROGLEY

of Rt. 2, Box 8, Salem, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well

a tributary of Willamette River for the purpose of irrigation of 10.0 acres

under Permit No. G-1336 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 27, 1959

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.13 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within Smart DLC 42, Section 34, T. 6 S., R. 3 W., W.M.; Well is 835 ft. N. and 673 ft. W. from S.E. corner DLC 42.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.2 acres Lot 4 (SE $\frac{1}{4}$ NW $\frac{1}{4}$)
7.8 acres SE $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within Smart DLC 42
Section 34
T. 6 S., R. 3 W., W.M.

Land on which water is to be used is part of that described as follows:

Beginning at an iron pipe which is 178.00 ft. N. 89° 42' E. and 574.20 ft. N. 0° 07' E. from the SE corner of the James Smart DLC in T. 6 S., R. 3 W., W.M. in Marion County, Oregon; thence S. 89° 42' W. 821.90 ft. parallel with the S. line of said James Smart DLC to an iron pipe; thence N. 0° 07' E. 529.30 ft. to an iron pipe; thence N. 89° 42' E. 821.9 ft.; thence S. 0° 07' W. 529.30 ft. to the place of beginning and containing 10.00 acres of land.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
