CERTIFICATE OF WATER RIGHT

This Is to Certify, That **LILLIAN B. GLENN**, Successor in interest to **97801 Sophie Byers** of **211 N. W. 5th, Pendleton**, State of **Oregon**, has a right to the use of the waters of **Umatilla River**, a tributary of the **Columbia River**

for the purpose of **irrigation of 29.4 acres and stock use**

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for **Umatilla** County, and the said decree entered of record at Salem, in the Order Record of the **STATE ENGINEER**, in Volume **3**, at page **127**; that the priority of the right thereby confirmed dates from **1895**

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.36 c.f.s.** subject to the provisions of paragraph **33** of said decree and all other conditions and limitations contained in said decree.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

17.6 acres NE $\frac{1}{4}$ NE $\frac{1}{4}$
 4.6 acres NW $\frac{1}{4}$ NE $\frac{1}{4}$
 7.2 acres SE $\frac{1}{4}$ NE $\frac{1}{4}$

NOTE: Certificate of Water Right issued to Sophie Byers and recorded at page 2498, Volume 3, State Record of Water Right Certificates, confirms a right to the use of water for irrigation and the development of power. Subsequently, the right for the development of power was canceled by order of the State Engineer entered October 24, 1961, pursuant to the provisions of ORS 543.730. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to Sophie Byers, and to confirm a change in point of diversion approved by an order of the State Engineer entered September 21, 1961 pursuant to the provisions of ORS 540.510 to 540.530.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
