**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That ORVAL C. SETTLES**

of **Star Rt. Box 30, Philomath**, State of **Oregon**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **unnamed stream**

a tributary of **Gellatly Creek - Mary's River** for the purpose of **domestic, including irrigation of not to exceed  $\frac{1}{2}$  acre lawn and garden**

under Permit No. **23826** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **August 19, 1955**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.01 cubic foot per second**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **(SW $\frac{1}{4}$  SW $\frac{1}{4}$ )** as projected within **Wood DIC 64, Section 18, T. 11 S., R. 6 W., W. M.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to \_\_\_\_\_ of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

**T. 11 S., R. 6 W., W. M.**

Land on which water is to be used is part of that described as follows:

Beginning at the northwest corner of the tract described in the deed recorded in Book 78, page 160, Benton County Deed Records; thence along the lines of said tract S 0° 06' W 454.0 ft. and S 89° 54' E 180.0 ft. to the northwest corner of the tract of land described in the deed recorded in Book 147, page 372, Benton County Deed Records; thence S 0° 06' W along the west line of the last mentioned tract 300.0 ft. to the southwest corner thereof; thence N 89° 54' W along the south line of last mentioned tract extended westerly 647.94 ft.; thence N 0° 06' E, parallel to the west lines of said tracts, 557.50 feet to the southerly right-of-way line of the Corvallis-Newport Highway; thence northeasterly along said right-of-way, 507.47 feet to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
