CERTIFICATE OF WATER RIGHT

This Is to Certify, That T. J. WILLEY

of **Route 2, Box 345, Creswell**, State of **Oregon**, has made proof to the satisfaction of the **STATE ENGINEER** of Oregon, of a right to the use of the waters of **Coast Fork Willamette River**

a tributary of **Willamette River** for the purpose of **irrigation of 23.7 acres**

under **Permit No. 25028** of the **State Engineer**, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **June 27, 1957**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.27 cubic foot per second**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **SE $\frac{1}{4}$ NE $\frac{1}{4}$** , as projected within **Whittimore DIC 82, Section 30, T. 18 S., R. 2 W., W. M.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$ acre feet per acre** for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.2 acre NW $\frac{1}{4}$ NW $\frac{1}{4}$ as projected within Whittimore DIC 82
 12.2 acres SW $\frac{1}{4}$ NW $\frac{1}{4}$ as projected within Whittimore DIC 82
 2.4 acres SW $\frac{1}{4}$ NW $\frac{1}{4}$ as projected within Bowman DIC 78
 0.8 acre SE $\frac{1}{4}$ NW $\frac{1}{4}$ as projected within Bowman DIC 78
 1.5 acre NE $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within Bowman DIC 78
 4.5 acres NW $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within Bowman DIC 78
 2.1 acres NW $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within Whittimore DIC 82

Section 29

T. 18 S., R. 2 W., W. M.

Land on which water is to be used is part of that described as follows:

Beginning at a point 27.98 chains S. of the most N'ly N.W. corner of the Bowman DIC 78 and run thence S. 5.36 chains to the corner in angle of said Claim, thence E. 17.60 chains, thence N. 5.05 chains, thence E. 3.76 chains, thence N. 31 links, thence W. 21.36 chains to the place of beginning.

ALSO, beginning at the Stone which marks the re-entrant angle in the Bowman DIC 78 and run thence W. 451.5 ft. to the centerline of the County Road, thence N. 0° 31' E. 1306.0 ft., thence N. 15° 58' W. 140.5 ft., thence N. 48° 36' E. 85.5 ft., thence E. 414.4 ft. to the W. line of said Bowman Claim, thence S. along said line 1497.5 ft. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
