CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That C. J. ALLEN

of Wallowa, State of Oregon has a right to the use of

the waters of East Fork of Bear Creek, Spring and Spring Branches, Spring Branch, and South Fork of Wallowa River, tributaries of Wallowa River

for the purpose of the irrigation of 725 acres of land, domestic and stock use

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for

Wallowa County, and the said decree entered of record at Salem, in the Order Record of the State Water Board of the State of Oregon, in Volume 5, at pages 143-144;

that the priority of the right hereby confirmed dates from June 17, 1893 for Tract No. 1; 1878 for 40 acres, 1884 for 70 acres and 1885 for 15 acres, all included in Tract No. 2; 1890 for Tract No. 3 and 1889 for Tract No. 4

that the amount of water to which such right is entitled and hereby confirmed for the purposes

aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1 1/2 acre feet per acre during any period of 30 days prior to July 31st of each year, and thereafter not to exceed 1 acre foot per acre during the entire remainder of the irrigation season; and said right shall be subject to all other conditions and limitations contained in said decree.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use,

is as follows: Tract No: 1, irrigated from East Fork of Bear Creek: 2 acres in the NE 1/4 NW 1/4; 42 acres in the NW 1/4 NW 1/4 (Lot 4) 40 acres in the SW 1/4 NW 1/4; 5 acres in the SE 1/4 NW 1/4; 27 acres in the NE 1/4 SW 1/4; 40 acres in the NW 1/4 SW 1/4 of Section 5; 42 acres in the NE 1/4 NE 1/4 (Lot 1); 42 acres in the NW 1/4 NE 1/4 (Lot 2) 37 acres in the SW 1/4 NE 1/4; 40 acres in the SE 1/4 NE 1/4; 37 acres in the NE 1/4 NW 1/4; 5 acres in the NW 1/4 NW 1/4; 8 acres in the SE 1/4 NW 1/4 and 28 acres in the NE 1/4 SE 1/4 of Section 6, Township 1 South, Range 43 East of Willamette Meridian, also 40 acres in the SE 1/4 SE 1/4 of Section 31, Township 1 North, Range 43 East of Willamette Meridian.

Tract No. 2, irrigated from Spring and Spring Branches; 20 acres in the NE 1/4 SW 1/4; 40 acres in the NW 1/4 SW 1/4 of section 5; 37 acres in the NE 1/4 NW 1/4; 3 acres in the NW 1/4 NW 1/4 and 25 acres in the NE 1/4 SE 1/4 of Section 6, Township 1 South, Range 43 East of Willamette Meridian. (This right is supplemental to water used through Allen Water Ditch from East Fork of Bear Creek for the above described lands)

Tract No. 3, irrigated from Spring Branch: 5 acres in the SW 1/4 NE 1/4 of Section 5, Township 1 South, Range 43 East of Willamette Meridian.

Tract No. 4, irrigated from South Fork of Wallowa River: 42 acres in the NW 1/4 NE 1/4; 35 acres in the SW 1/4 NE 1/4; 40 acres in the NE 1/4 NW 1/4. 35 acres in the SE 1/4 NW 1/4 and 8 acres in the NE 1/4 SW 1/4 of Section 5, Township 1 South, Range 43 East of Willamette Meridian.

All of the above described lands being in Wallowa County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
